Once the registration strategy is determined, CSI will function as Agency liaison and will manage registration dossier preparation and submission.

## State Registration Management

In the US, federal registration must be followed by state registration prior to distribution of a product to a given state. CSI manages first-time registrations in all 50 states, the District of Columbia, and US territories. We also carry this forward with annual renewal of product licenses and registration according to individual State schedules and fees. Non-FIFRA regulated products begin at the state level, where CSI consultants manage first-time registrations and appropriate renewals and tonnage reporting, where applicable. State registration packages are assembled to include state-specific application forms, product labels, MSDSs, technical data, authorization letters, and product summaries.

## Data Development, Study Placement & Monitoring

- Identification of required studies to support registration intent, and data gap analysis.
- Placement and monitoring of studies at contract research organizations (CROs).
- Review and interpretation of study results, assure compliance with Good Laboratory Practice (GLP) standards.

## Risk Assessment

CSI's consultants lend extensive experience in all aspects of human health and ecological risk assessment, including endangered species analysis and strategy, spatial analysis and data systems, and applied economic impact analysis and cost benefit assessment. This expertise will be applied during the process of registration applications as well as during registration review and data call-ins that arise during the lifetime of the product registration. This work is used to conduct hazard identification, effects analysis, exposure assessment, and risk characterization.

## Toxicology and Chemistry Consultation

CSI's multi-disciplinary team of scientists supports registration activities by providing expert guidance on toxicology, ecotoxicology, environmental fate, and product and residue chemistry aspects that will influence the product category, registration status, use restrictions, and tolerance considerations that must be evaluated prior to registration.
